High-Concept Pitch

Why This Story Works for Television

- **Multi-Season Potential:** 15 years of documented events spanning Macau, Vietnam, and the United States.
 - **Unprecedented Access:** First published account exposing Triad operations from a survivor's perspective.
 - **Verified Evidence:** Audio recordings, video footage, and screenshots that verify every major event.
 - **International Scope:** Exotic locations: Macau's neon-lit casinos, Vietnam's streets, American suburbs.
 - **Escalating Stakes:** From surveillance to poisoning attempts to elaborate blackmail schemes involving corrupt police.

Series Arc (3-Season Potential)

- **Season 1: The Trap (2009–2011):** Lured to Vietnam by the promise of love after meeting Hong, a Triad-controlled sauna worker, on a guys' trip to Macau, Edward soon finds himself ensnared in a long-term scam. Once in Vietnam, he becomes the target of the Triads, local police, and his future wife and mother of his child. He must escape plot after plot, surviving attempts on his life and repeated criminal frame jobs, as the true scope of the conspiracy is revealed.
- **Season 2: Nowhere to Run (2011–2015):** The danger intensifies across Vietnam as Edward faces escalating attacks and attempts to frame him using corrupt police, fake nurses, and planted evidence. The Triad's reach proves global.
- **Season 3: The Long Game (2015–Present):** Years of psychological warfare and ongoing threats push Edward to meticulously document every event, culminating in the publication that exposes the entire operation and the people behind it.

Character Breakdown

- **Edward Jamison (Protagonist):** Duquesne Law School graduate, practicing attorney, founder of Jamison Law Group. An everyman thrown into extraordinary circumstances who refused to break under 15 years of attacks.
- **Luis (Primary Antagonist):** Triad Godfather orchestrating the operation from Macau.
- **Hong:** Central figure in the scam; Edward's romantic partner whose manipulation and betrayal drive much of the psychological tension. She later becomes the mother of Edward's son and his wife, making her role both deeply personal and pivotal to the story's escalation.
- **"7":** Female Triad boss and mastermind, orchestrating complex scams and power plays.
- **John Lam:** 7's future Chinese husband and Triad operator whose betrayal and later confession are pivotal to the story's escalation.
- **Hanna:** Companion-for-hire at a Macau club where men could select women for paid company. Her sharp wit and emotional complexity draw Edward into a parallel romance, exposing the transactional and manipulative nature of the Triad's scheme.
- **Nhan:** 7's sister and the principal translator for both Hong and Hanna. Her presence enables communication and, at times, subtle manipulation between Edward and the women at the heart of the Triad's operation.

- **Jeff:** Edward's longtime friend and fellow attorney who persuades him to take the fateful trip to Macau: unwittingly setting the story in motion.
 - **Freddie:** Part of the original "guys' trip" to Macau, Freddie provides a baseline for what a typical tourist might experience, highlighting the extraordinary nature of Edward's ordeal.
 - **Edward's Son:** Born in Vietnam in 2010, he becomes an anchor for Edward's resolve and survival. His presence raises the stakes of every decision, especially during the harrowing escape from Vietnam. Though young, he embodies the story's themes of innocence at risk and the enduring bond between father and child.
 - **Psychic Medium Ally:** A psychic medium who provides Edward with crucial warnings and psychological support, blurring the line between crime and supernatural manipulation. Her involvement begins in Season 3.
 - **Isa:** Edward's best friend and emotional anchor during his returns to the US.
 - **Johnny:** Edward's loyal friend who travels to Vietnam for his wedding and later returns to help him during the critical 2011 move. Johnny provides support and a tangible connection to Edward's old life as the danger escalates.
 - **Supporting Characters:** Corrupt police officers, fake medical staff, and a network of Triad collaborators spanning three countries.
